

Newport Soccer Camp

Medical, Liability, and Publication Release Form

I, the parent or legal guardian of _____ (the "Player"), give permission for the Player to receive emergency medical or surgical treatment and hospitalization if necessary. I hereby authorize the directors, coaches, staff, and associates of Newport Soccer Camp (NSC) to act on my behalf according to their best judgment in any emergency requiring medical or surgical treatment and hospitalization if necessary. I certify that the Player is physically able to participate in the Newport Soccer Camp and that I know of no restrictions, physical impairments, or any other facts, which in any manner limit his/her participation in such a program. I also understand that Newport Soccer Camp will administer no physical examinations and that Newport Soccer Camp will rely solely upon the information shown on this form. I hereby waive and release Newport Soccer Camp and its Coaches, Staff, Camp Management, Directors, Sponsors and Representatives from any liability for any injury or illness incurred while at camp.

I UNDERSTAND THAT THERE IS RISK OF INJURY TO THE PLAYERS AS A RESULT OF CAMP ACTIVITIES, AND KNOWINGLY AND VOLUNTARILY ASSUME ALL RISK OF SUCH INJURY. CAMP ACTIVITIES INCLUDE ANY TRAINING, TRAVEL, MEAL, LODGING, OR ASSOCIATION WITH THE CAMP.

I will be financially responsible for any medical attention needed during the camp or resulting from an injury received at camp. My medical insurance shall be the insurance coverage for any medical treatment. I further understand Newport Soccer Camp retains the right to use, for publicity and advertising, photographs of campers taken at camp.

LIMITATION OF LIABILITY. I agree that the total cumulative liability of Newport Soccer Camp its affiliates and respective directors, officers, employees, and agents with respect to services performed or to be performed by Newport Soccer Camp, whether for breach of contract, contribution, tort or other theory of liability, shall not exceed 100% of the compensation received by Newport Soccer Camp, from me pertaining to Player. The parties agree and acknowledge the Section of the Agreement as a material part of the consideration for the Agreement.

PLAYER'S RELEASE OF LIABILITY. I agree to hereby release, forever discharge Newport Soccer Camp, from any and all claims, debts, costs, obligations, promises, acts, agreements, actions and causes of action, demands, damages, counterclaims, set-off, or liabilities (including attorneys' fees and costs), whether past, present, or future, arising from or related to any acts, actions, failures to act, or to any of the matters relating to an injury or other liability resulting from my or Player's disregard or failure to follow Newport Soccer Camp rules and etiquette.

PLAYER'S INDEMNIFICATION OF INSTRUCTOR. I agree to indemnify and hold Newport Soccer Camp its affiliates and respective directors, officers, employees, and agents harmless from any action arising out of my or the Player's failure to follow Newport Soccer Camp rules and etiquette, including all judgments, attorneys' fees and costs, incurred by Newport Soccer Camp.

CAMPER RESPONSIBILITIES. Newport Soccer Camp is interested in making the Player's camp / clinic experience safe, challenging, happy and rewarding. For this reason we hold high expectations for the Player behavior. Players must agree to comply with the rules and standards of Newport Soccer Camp, and to be a positive influence in the camping program. Players and their parents/ guardians must understand that dismissal from camp could happen without tuition refund, if behavior or attitude is unacceptable as determined by the Camp Director.
